

**2020 Youth Vendor Guidelines for Ferryville Farmers Market**

- **Ferryville Farmers Market will be open Saturdays only May 16 – October 31, 2020.** Hours 9 am to 3 pm
- Vendor fee will be waived the first year for Youth Vendors. (2<sup>nd</sup> year half fee of \$2.50/Sat. or \$25.00 seasonal fee – 3<sup>rd</sup> year full seasonal fee of \$50)

Participants must have a ride to and from the market. They have to have their own change box, dress appropriately (example t-shirt – shorts/jeans and shoes), and must have own signage, labeling and pricing.

Participants must contact market manager by email, text or phone if they are not coming to the market on any particular Saturday.

We encourage vendors to have local grown produce/products. All home-canned products must be labeled using USDA guidelines. (Name of product, ingredients, vendor name and address, not produced in a commercial kitchen, etc.)

- If a Vendor wants to use the Park for camping for the night they are required to Pay \$10.00 per night for camping (placed in the Village collection box)
- Set up will be 6 ft. back from the edge of the roadway or gravel.
- Food being prepared and consumed for sale and on the Ferryville Farmers Market premises requires appropriate State License and certificate of liability insurance furnished to the Village of Ferryville, PO Box 236, Ferryville, WI 54628 in advance.
- No firearms, fireworks or alcohol will be sold
- Picnic Tables are for Public Use and not to be moved. Please don't use for your products.
- No pets in Market area
- **Vendors must leave their sites with “nothing left behind”. If by chance a vendor would like to leave a small amount of garbage, only one closed plastic bag left by garbage receptacle.**
- **The Ferryville Farmers Market and the Village of Ferryville do not provide any liability Insurance coverage for Vendors or for products sold by vendors. Vendors agree to assume full liability for any loss, injury or for property loss owned by vendors participating in “Ferryville Farmers Market”.**
